United Electric "Shine the Light" Scholarship Program

Dear Student:

Thank you for your interest in and taking the time to apply for a United Electric "Shine the Light" Scholarship! To ensure we have all the information we need, and to evaluate your application, please be sure to include your member account number above.

Two well established Cooperative principals include concern for communities, and education and training for our members. In keeping with these traditions, the Board of Directors of United Electric has decided to reinvest returned, unclaimed capital credits back to the community by providing educational scholarships to our members.

Several years ago, as a result of Pennsylvania's lobbying efforts in Harrisburg, Pennsylvania Electric Cooperatives are now able to use their escheated money within their local communities. Escheated money is capital credits from former members that have been unclaimed; and the members have not been able to be located for 3 years. Legislators have agreed to allow the Cooperatives to use funds locally for specific causes.

United Electric Cooperative is now offering Scholarships to members and dependents of members who have been members for at least one year.

Who is eligible?

Sons and daughters of members of United Electric Cooperative Inc., as well as any adult learner, who is a member, pursuing an advanced education degree or certificate. Applicants must be able to prove enrollment in an accredited school, working toward a minimum of a Certificate, associate degree, bachelor's degree, master's degree or higher. The Board of Directors will determine the number and amount of the scholarships.

Important dates to remember!

All applications AND proof of enrollment must be received no later than April 15, 2025. Scholarship awards will be announced by June 1, 2024. Scholarship checks will be mailed directly to the institution by June 30, 2025.
