AT UNITED ELECTRIC COOPERATIVE, we are constantly striving to improve our processes so we can make our cooperative better for our members. By making sure we have accurate and complete contact information for you, we can continue to provide the high level of service you expect and deserve.

This information is important because we can only discuss the account with the member(s) listed on it. We sometimes must verify names, phone numbers and additional personal information. When more than one adult lives in a residence, it's often assumed both are

on the account, but that's not always the case. Full and accurate contact information is especially important for discussions about past-due amounts, fees and payment assistance.

As we move into winter, some members may be unable to keep up with their utility account balances. If you need assistance paying your heating bills, there are many agencies and programs in our area that offer financial assistance to alleviate some of the burden:

- ▶ LIHEAP (Low Income Home Energy Assistance Program) At presstime, we learned that due to the federal government shutdown, the opening date of LIHEAP has been delayed from Nov. 3 until at least Dec. 3. As a result, the state Department of Human Services will not be accepting applications for regular LIHEAP cash or crisis grants until the season opens. As always, we will keep our members informed as updates become available. For more information, please call the cooperative office or the county agencies listed below.
- ▶ United Electric also offers our **Members United Program**, which provides assistance up to \$500 and is funded through our Round-Up Program. Please contact our Member Services Department toll-free at 888-581-8969 to inquire about current eligibility and guidelines. Program caseworkers will call United Electric to verify and retrieve information, which is why providing your current contact information is important.
